- 2. The candidates whose names are shortlisted have been provisionally called for Personal Interview (PI) based on the entries made by them in the ONLINE application for the above post subject to fulfilling the requisite eligibility criteria as stipulated in the Advertisement. If at any stage of the recruitment process including after recruitment or joining, it is detected that information provided by him/her is incorrect/incomplete/false or is not in conformity with the eligibility criteria as prescribed in the relevant Advertisement/Notification, or if it is found that he/she has concealed/distorted any material information, his/her candidature/appointment will be cancelled without assigning any reason thereof.
- 3. While every care has been taken in preparing the list of provisionally eligible candidate, DVC reserves its right to rectify any fact-based inadvertent error or typographical mistake.

 - e) Experience Certificate(s)
 - f) Pay equivalency certificate proof.
 - g) Last Pay Certificate (LPC)
 - h) Four recent passport size colored **photographs** duly self-attested.
 - i) Any one Photo Identity Proof (PAN card/ Passport/ Driving License/ Voter ID card/

Aadhar Card).

- j) Documents / Certificates in support of any other additional qualification/ experience mentioned in the online application.
- k) NOC OR Forwarding letter from parent organization alongwith vigilance clearance certificate and Attested copies of ACR of last five years (from 2018-19 to 2022-23). If candidate appears on the date of Interview without proper forwarding letter of his/her parent organization, then he/she may not be allowed to appear for Interview.
- I) Bank Details (Account No., IFSC Code, MICR Code, etc.) and/or cancelled cheque / passbook photocopy (in which bank details are mentioned) for reimbursement of to & fro Air/railway fare, as applicable.
- 6. Mere appearing or shortlisting for the personal interview does not bestow upon the candidate any right to be selected suo moto to the post applied for.
