## LIST OF PROVISIONALLY SHORTLISTED CANDIDATES FOR DOCUMENT VERIFICATION AND IMPORTANT INSTRUCTIONS

- 1. The list of candidates whose names are shortlisted have been provisionally called for **Document Verification (DV)** based on the credentials furnished by them in the ONLINE Application for the Post of **Junior Engineers Gr.II (JE Gr.II)** in DVC. If at any stage of the recruitment process including after recruitment or joining, it is detected that information provided by him/her is incorrect/incomplete/false or is not in conformity with the eligibility criteria as prescribed in the relevant Advertisement, or if it is found that he/she has concealed/distorted any material information, his/her candidature/appointment will be cancelled without assigning any reason thereof.
- 2. The shortlisting of candidates is provisional. Final selection is subject to meeting all the requirements as laid down in the Advertisement and verification of all the required documents and credentials as furnished by the applicants in their **ONLINE application**.
- 3. The candidates have been shortlisted in the ratio of 1:3 for Document Verification (DV) in the order of merit of Computer Based Test (CBT) marks (obtained out of 100) as per category-wise vacancies in each discipline including PwD.
- 4. In case two or more candidates in the same discipline and category secured equal marks in CBT and the ratio of 1:3 is increasing, all those candidates who secured equal marks will be called for Document Verification irrespective of the above ratio.
- 5. In case of tie at cut-off level, i.e., more than one candidate scoring same CBT marks (out of 100) at cut-off level, preference in selection shall be given to the candidate who is senior most in age according to the Date of Birth.
- 6. <u>The following Documents to be brought mandatorily in ORIGINAL along with one set of self-attested photocopies positively for Document Verification (DV): -</u>
  - i. Printout of ONLINE Application Form.
  - ii. Candidate's copy of the admit card
  - iii. Proof of Date of Birth (Class 10<sup>th</sup> Board Certificate or Class 10<sup>th</sup> Passing Certificate)

- iv. Valid Certificates & Mark sheets of Class 10th, 12th,
- v. Valid Diploma Certificate and semester-wise marksheets.
- vi. Proof of Percentage Conversion Formula, if applicable (issued by University/Institution)
- vii. Valid SC/ ST/ OBC (NCL)/ EWS certificate, as applicable in the prescribed format (as applicable for appointment to posts under the Government of India.)
- viii. **Disability Certificate in case of PwD candidate** in prescribed GoI format from Competent Authority/ Medical Board.
- ix. In case of OBC (NCL)/ EWS, certificate must not be older than 1(One) year from the date of Document Verification (See Annexure-1 to 4 under Careers (Recruitment Notices) on DVC website) for prescribed GOI format of Community/Caste Certificates, Income & Asset Certificate & Disability Certificate, etc.).
- x. Valid **Age relaxation cum Domicile Certificate / Discharge Certificate**, etc., if applicable in the prescribed format issued by a competent authority.
- xi. Valid Experience Certificate(s), if applicable.
- xii. **No-Objection Certificate (NOC)** from the current employer in respect of candidates employed with Central/State Govt./Quasi Govt. offices/Public Sector Undertaking, Autonomous Bodies, etc.
- xiii. Application Fee Payment Acknowledgement e-Receipt, if applicable.
- xiv. Four (4) recent passport size-colored photographs.
- xv. Identity Proof (Aadhaar Card/PAN card/ Passport/ Driving License/ Voter ID card).
- xvi. Documents / Certificates in support of any other additional qualification / experience mentioned in the application.
- In case a candidate is unable to produce NOC from the current employer at the time of Document Verification, then an Undertaking will be taken from the candidate to submit Relieving/Release Order at the time of joining, if selected.
- 8. Candidates appearing for **Document Verification** without proper Certificates/Documents will do so only at their own risk for which DVC shall not be responsible.
- The Venue for Document Verification is 12<sup>th</sup> Floor, Dr. Meghnad Saha Auditorium, DVC Towers, VIP Road (near Ultadanga), Kolkata-700054 from 10:00 A.M onwards as per the Schedule mentioned below.
- 10. Candidates are advised to make their own arrangements for their travel and stay well in advance, so as to reach the Venue on time and also to come prepared for stay at Kolkata in case Document Verification continues on the next day.
- 11. Mere appearing of name in the shortlisted list or mere appearing for Document Verification (DV) does not bestow upon the candidate any right to be selected suo motu to the Post applied for or does not guarantee issuance of offer of appointment.

- 12. If candidates fail to bring all the required documents/certificates in <u>ORIGINAL as mentioned</u> <u>above</u> or if at the time of Document Verification, it is detected that document/certificate provided by the candidate is incorrect/incomplete/false or is not in conformity with the eligibility criteria as mentioned in the relevant Advertisement, or if it is found that he/she has concealed/distorted any material information, the candidature of such candidates will be treated as cancelled and such candidates shall not be eligible for further process.
- 13. The eligibility of the candidate will be ascertained after Document Verification.
- 14. On successful completion of the Document Verification, **"Offer of Appointment"** will be issued to the candidates who have been found eligible as per the eligibility criteria as mentioned in the Advertisement.
- 15. Issuance of Appointment Offer will be considered subject to appearing in the Document Verification and based on the vacancies as notified.
