Technical Qualifying Requirement for uniform Road mode coal transportation contract:

Technical Credential

The bidder should meet the qualifying requirements stipulated hereinunder:

The indenting bidder may quote for any individual slab, or all the slabs as indented by specific plant.

If the bidder quotes for any one slab, then they are required to meet the QR as mentioned below against that respective slab only. However, if the bidder quotes for more than one slab, then they are required to meet the QR accordingly as mentioned below against the respective combination of slabs.

Qualifying Requirements on Technical Capability:

The bidder should have experience of completing similar works within India during last 07 years ending last day of month previous to the one in which the offer is invited and shall be either of the following:

- a) Three similar executed works each costing not less than the amount equal to 40% of the estimated Cost, or
- b) Two similar executed works each costing not less than the amount equal to 50% of the estimated Cost. or
- c) One similar completed work costing not less than the amount equal to 80% of the estimated Cost.

NOTES for Technical Criteria for all clauses of Sl. No. 1 above:

The bidder should have experience of completing similar works within India during last 07 years ending last day of month previous to the one in which the offer is invited and shall be either of the following:

- c) One similar completed work costing not less than the amount equal to 80% of the estimated Cost.

NOTES for Technical Criteria for all clauses of Sl. No. 1 above:

1. Technical Credential

The bidder should have experience of completing similar works within India during last 07 years ending last day of month previous to the one in which the offer is invited and shall be either of the following:

- a) Three similar executed works each costing not less than the amount equal to 40% of the estimated Cost, or

b) Two similar completed works each costing not less than the amount equal to 50 % of the estimated cost.

Or

c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

Notes for Technical Criteria:

- 1. Similar Work means: Work Order/ AMC/ RC/ Purchase Order for Topographical Survey or Physical
 - verification of coal/ Minerals/ Slag / Sand/ Earth/ Colliery/ Mines/ Coal yard/stockpiles of road/ stockpiles of rail/stockpiles of open ground of any Public Sector Undertaking/ Govt. of India / Semi Govt. organizations/Joint sector enterprises (managed jointly by Govt. and Others Agency)/ Public Limited company/ Private Limited as a contractor under its own capacity and accountability to any beneficiary within India.

Completed Work means: The executed/ completed/ delivered portion of Work Order/ AMC/ RC/ Purchase Order, Payment receipt documents with ref. to WO No. and date or execution certificate with executed value and referred order no. may also be considered as a proof of execution/delivery even if the works have not been completed in totality (subject to furnishing proof of executed/supplied value of works in the form of certified copies of RA Bills) or any relevant documents, which is sufficient to proof the works completed/delivered or to be completed.
