# TECHNICAL QUALIFYING REQUIREMENT for HIRING OF DIESEL SHUNTING LOCOMOTIVE (Broad-Gauge) of capacity 1400HP or equivalent or higher capacity.

#### **Technical Credentials: -**

- A. The bidder should have experience of completing similar works during last 07 years ending last day of month previous to the one in which the offer is invited and shall be either of the following:
  - 1. Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

OR

2. Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.

OR

3. One similar completed work costing not less than the amount equal to 80% of the estimated cost.

### i. SIMILAR WORK MEANS: -

The firm should have experience of <u>engagement</u> / <u>operation & maintenance</u> of Diesel Locomotive Engine of minimum 800 HP or above capacity for placing/shunting of loaded/empty rake under public sector undertaking/govt./ semi govt. organizations/joint sector enterprises (managed jointly by Govt. and Others Agency)/Public Limited company/Private Limited company and successfully executed the contract.

- ii. COMPLETED WORK MEANS: Work order/s, payment receipt documents with reference to the Work Order no and date or successful job completion certificate/s in respect of executed/completed portion of work order with executed value even if the work has not been completed in totality (Subject to furnishing proof of executed value of the work in the form of certified copies of RA bills shall be considered or any relevant documents, which is sufficient to prove the works completed or to be completed).
  - B. The bidder should be owner/freehold or leasehold of the Diesel Locomotive Engine (Broad-Gauge) of minimum 1400 HP or equivalent or above capacity to be deployed and ownership document/leased agreement of possession should be furnished with the techno-commercial bid.

OR

In case the bidder intends to hire the Diesel Locomotive Engine (Broad-Gauge) of minimum 1400 HP or equivalent or above capacity to be deployed, bidder shall be in agreement with the owner of the equipment in this regard. The agreement shall clearly mention that the owner of the equipment shall, in the event of placement of order on the bidder against the NIT, hand over the Diesel Locomotive Engine to the bidder within a period of 07 days from the date of order. Copy of the agreement of hiring along with ownership documents of the equipment shall be furnished with the techno-commercial bid.

### Note:-

- All the figures to be mentioned above to be considered exclusive of GST.
- 2. Joint ventures (JV) / Associates are also eligible to participate as per stipulation in W&P manual-2022.
