SIDHNATH SINGH	Single (Urgency)	considering COVID scenario it has been decided in morning meeting on Saturday i.e. 10.0 4.2021 to start spraying chlorinated water through sprinkler tanker in the colony area as a precautionary measure in view of outbreak of COVI D-19. Also 6 nos manpower has been engaged for sanitizing buildings manually through handheld sprayer machine as per direction. Since there was no departmental arrangement for spraying the same, it was decided to execute the work through agency. In this work it was needed to sanitize at desired places by spraying chlorinated water for 60 (Sixty) days. Every day spraying of chlorinated water was done in four trips with 50001 capacity tanker around the BTPS colony. In view of current situation and COVID guidelines the work has already been started from 10.04.2021.
