Suspension Notice from participating in any tender of DVC

Sub.: Tender for "Annual Rate Contract for Mechanical maintenance of Ash Handling Plant including round the clock Operation assistance of Ash Handling System and Upkeepment & removal of technological waste of Unit#1 & 2 (2X500 MW) of DSTPS, DVC for a period of 2 years"

7. An Incident raised on GeM portal on 13/05/2024 and escalated on 18/05/2024 from DVC regarding non-responsive nature of L1 bidder.
8. Reply email dated 22/05/2024 of L1 bidder regarding non-acceptance of their final concluded price after e-reverse auction.
9. Vide email dated 22/05/2024 of DVC, L-1 bidder (M/S RAMESH SHARMA & CO.) was informed that necessary action will be taken against you as per terms & Conditions of GeM and DVC.
10. GeM had suspended the L1 bidder w.e.f. 24/05/2024 from GeM portal upto 23/06/2024 due to not receipt of any reply from L1 bidder.
11. Cancellation of the tender of ref. (1) above vide no. DVC/Tender/Head Quarter/AHP Maint./CMM/Works and Service/ 898 Date: 21 /06/2024

Dear Sir,

- i) WHEREAS, subject tender has been issued on GeM portal on OTE with e-Reverse auction basis vide ref.(1) above. On opening of the tender, your offer against the tender was accepted and on scrutiny your offer was found techno-commercially compliant. price bid of the above ref. tender was opened on 15.04.2024 e-reverse auction concluded on 19/04/2024 at 10:00 hrs. and accordingly, you are emerged as L1 bidder.
- ii) WHEREAS, as per terms & conditions of GeM bid after e-reverse auction, you have to submit the price break up immediately after concluding the e-reverse auction and Produce/submit the supporting documents (Hard copies in original /self-authenticated and attested by Public Notary) as per NIT to C&M Dept., DVC, HQs, Kolkata for the purpose of verification. An email dated 20/04/2024 sent to you in this regard.
- iii) WHEREAS, it has been seen that after conclusion of e-reverse auction you were not responded even after several communication (ref. 2 to 5). A letter towards final request was sent to you vide ref. (6) above for submitting the reply in line with the email vide ref. (2) above, but you did not reply within the stipulated time frame.
- iv) WHEREAS, an incident raised on GeM portal on 13/05/2024 and escalated on 18/05/2024 from DVC regarding your non-responsive nature.
- v) WHEREAS, vide email dated 22/05/2024 you have informed that you could not continue with your e-reverse auction final concluded amount means you are unable to accept your final concluded price after e-reverse auction.
- vi) THEREFORE, GeM portal has suspended you w.e.f. 24/05/2024 for one month i.e. upto 23/06/2024 due to your non responsive nature.
- vii) As per Terms & Conditions mentioned in the attached IFB of GeM bid in the event of L-1 bidder refusing to give breakup of price and in the event of a L-1 bidder backing out prior to placement of order, the bidder shall be suspended for a period of six months from the date of issue of suspension order. During suspension period, enquiry shall not be issued to the firm and bid submitted in open tender shall be rejected.
- viii) In view of the above, NIT/BID under ref.(1) above was cancelled vide ref.(11).
- ix) Consequent upon the above, we are constrained to take the decision of six (06) months suspension w.e.f. 24/05/2024 (effective date of suspension from GeM) i.e. total suspension period of six months from 24/05/2024 to 23/11/2024.
- x) You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the Projects/Stations of DVC and in case you have participated in the tender process, but price bids are yet to be opened, your bids will be rejected. In addition to the above, you shall not be allowed to participate as an Associate for any of the tenders of DVC.

- xi) Please note that the **suspension of business dealings** shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.
- xii) This intimation is issued to you through registered/speed post after retaining a copy for our record.
