SUB: Debarment /Suspension order regarding participating in any tender of DVC .

Dear Sir,


- (I) WHEREAS tender for 'hiring of truck' was floated through GeM portal on OTE with RA basis under reference 1 & 2, in which you had participated. After techno-commercial evaluation and opening of the price part, reverse auction was conducted in GeM portal in which you emerged as the L-1 bidder. Further, you were asked to accept the price quoted by you with price breakup and SAC code in GeM portal. However, you replied that your quoted rates to be exclusive of GST. As per Corporation's rule , a show-cause notice was issued to you vide letter no. DVC/Tender/BTPS/MS-II A/C&M/Works & Service/ 00019/866 dtd 11.12.2023 in which you were asked to submit your representation on the case against which you have furnished a reply , which was not satisfactory.
- (II) WHEREAS an Incident was raised in GeM portal (Incident Number - 1797338) against you under clause " Fails to produce the requisite documents/ information/ certificates/test reports etc." on 22.01.2024 . The incident has been 'escalated' when the issue was not resolved. Further, GeM Admin has issued a 'show-cause notice' to you as per the laid down policies of GeM portal on 05.02.2024. Further, you have raised a 'mutual resolution request' on 06.02.2024 for resolving the matter . However, you once again have mentioned that your quoted rates are exclusive of GST. Hence, we have rejected your request on GeM portal .

- (III) In view of the above, we are constrained to take the decision of suspension of business dealings with your firm for a period of one (01) year from the date of issue of this intimation . You may note that during the said period, you shall not be allowed to participate in any tender enquiry in any of the projects / stations of DVC and in case you participated in the tender process , but price bids are yet to be opened , your bids will be rejected. In addition to the above, you shall not be allowed to participate as an Associate for any of the tenders of DVC.
- (IV) Please note that the suspension of business dealings shall be without prejudice of any rights of DVC and in addition to our rights to take such further actions at our discretion as are warranted in this regard at your sole risk as to the costs and consequences.

This issues with approval of the competent authority and in the interest of Corporation work.
