Under the provisions of MSMED Act, 2006, this Ministry, vide notification no. 2119(E) dated 26.06.2020 (copy enclosed), has notified composite criteria of classification of MSMEs based on investment in plant and machinery or equipment and turnover. It has come into force w.e.f. 01.07.2020. This revision in criteria of classification of enterprises as Micro, Small and Medium enterprises (MSMEs) was announced in the Atmnirbhar Bharat package on 13th May, 2020 by the Government.

- 2. On the basis of the revised criteria of classification, this Ministry has developed Udyam Registration (UR) Portal by replacing the earlier Udyog Aadhar Memorandum (UAM) Portal. Any MSME can register itself on the UR portal of the Ministry. The process is online, paperless and hassle-free and requires only Aadhar and PAN. Data as regards to investment in plant and machinery or equipment, turnover and exports are populated directly from the Income Tax and GSTN databases. The facility of verification of Udyam Registration has been provided on the UR portal and any Ministry can use such facility online through API-led verification process. The Udyam Registration Portal has a facility through which an entrepreneur can opt for linking himself with Government e-market (GeM) by selecting an option on Udyam Registration portal. With this facility, MSEs can link themselves with the Government's procurement system and can participate in the Government's mandatory program of procurement from MSEs. In addition to it, the portal has linkages with IT, GST and TReDs portals that will pave the way for formalization of the MSME sector.
- RBI has also made priority sector lending mandatory based on the Udyam Registration.
- 4. May I request you that Udyam registration may also be adopted as common identifier regarding different schemes being implemented for MSMEs by your Ministry and the same may be verified online and such data be made available to this Ministry by having API to link with the Udyam Registration portal. Such a process would bring in transparency, objectivity and information of various benefits being availed by the MSMEs, by Central Government Ministries. You are requested to indicate your requirements for an effective API interface between yours and our Databases. You may also like to nominate a nodal officer for the purpose, preferably, an officer not below the rank of Joint Secretary.
