Sub: Regulation of power to M/s Jharkhand Bijli Vitran Nigam Limited (JBVNL), due to part payment i.r.o. current energy bill.

Dear Sir,

It may kindly be intimated that due to part payment i.e. Rs. 100 Cr. against the current energy bills, the total undisputed dues cropped up to around Rs. 2110/- Cr. as on 31.10.2021. Further, JBVNL has not submitted any clear road map for liquidation of outstanding dues inspite of continuous persuasions vide DVC's letters under reference above. This is badly affecting DVC's working capital & DVC is not in a position to liquidate its liabilities mainly towards coal payment which in turn is affecting the generation of thermal power stations of DVC.

It is to be noted that as per clause- 6.2.9 of the PPA, if JBVNL fails to liquidate any dues, DVC is entitled to regulate the contracted capacity.

In view of above, DVC is going to regulate power of JBVNL (corresponding to the amount of current bill not being paid) from KTPSU#1&2 in terms of PPA & CERC Regulation as per following :

By 300 MW (50 %of 600MW) w.e.f. 00.00 Hrs of 06.11.2021

Regarding diversion/absorption of regulated share, if any response from the constituents is received, the same will be communicated to RLDC. As per requirement of CERC(Regulation of power Supply) Regulation, 2010 DVC is also posting Regulation Notice on DVC website: <http://www.dvc.gov.in>.

The regulation of power would be implemented w.e.f. 00:00 Hrs. of 06.11.2021 and onwards as per CERC Regulation/PPA. JBVNL will be liable to pay the fixed charges during the regulated period. A copy is being sent to SLDC, DVC Howrah to prepare implementation plan for regulation of power supply to JBVNL & implement the same as per procedure laid down by CERC(Regulation of power Supply) Regulations, 2010 and list of constituents who would avail the regulated power would be given to ERLDC within a week time.
