NOTICE

Jharkhand Bijli Vitran Nigam Limited (JBVNL), has defaulted in paying arrear & current monthly power supply bill of Damodar Valley Corporation (DVC). Total outstanding dues against JBVNL comes to amount of Rs. 4955 Crore up to consumption month of November'19.

Due to the above reasons DVC is constrained to regulate (disconnect the power supply) 50% of allocated power of M/s JBVNL, which will be enhanced by 10% in each subsequent day if no payment is received from JBVNL towards the above dues, effective from 00: 00 hrs of 25.02.2020 in terms of PPA & CERC Regulation as detailed below:

From KTPS U# 1&2 : 300 MW

TOTAL: 300 MW

In this connection, 15 days' notice has been served to JBVNL vide letter no. Coml/Export/JBVNL/2019-20/4999 dated 10.02.2020 in terms of the PPA executed with JBVNL & also considering CERC Regulation for default in payment for more than 45 days for suspension of allocated power to JBVNL. The suspension of power shall be effective after 15 days from the date of issuance of the said letter i.e. from 00: 00 hrs of 25.02.2020. The transmission of power shall commence only after all outstanding payments have been made.

Copy of the aforesaid letter has been forwarded to all concerned i.e. ERPC, ERLDC, MOP, Dy. Commissioner & Superintendent of Police of the concerned districts & Govt. of Jharkhand.

Inconvenience which is likely to be caused to the general public is attributable to the default of M/s JBVNL for which DVC is no way responsible.

Sub: Notice for Regulation of power to M/s Jharkhand Bijli Vitran Nigam Limited (JBVNL), due to default in payment to the tune of Rs. 4955 Crore upto consumption month of November'19.

Dear Sir,

We regret to inform you that DVC is yet to receive payment against our Power Supply Bills for an amount of Rs. **4955 Crs** which is overdue as on date.

In spite of our repeated requests for payment of monthly invoices within due date, JBVNL have miserably failed to pay the invoices, causing an outstanding amount of **Rs. 4955 Crs**. As per the terms of PPA & CERC/JSERC Regulation, the entire amount under the invoices is required to be paid in full within due date. M/S JBVNL have dishonored the terms of PPA & failed to pay the monthly invoices within due date.

The details of default amount are as follows:

Outstanding dues: Rs. 4955 Crs upto consumption month of November'19

It is to be noted that JBVNL have failed to liquidate the outstanding dues till date which has resulted in increase of substantial amount due to incidence of LPSC, in terms of the CERC/JSERC regulation.

This is badly affecting DVC's working capital. As a result, DVC is not in a position to liquidate its liability mainly towards coal payment which in turn affecting the generation of thermal power stations of DVC.

In view of above DVC propose to regulate **50%** quantum of allocated power of JBVNL in terms of PPA & CERC Regulation from following Stations:

From KTPS U#1&2 : 300 MW (50 % of 600 MW)

TOTAL

: 300 MW

If no payment is received from JBVNL towards the above dues, then the regulated quantum of 50% will be enhanced by 10% in each subsequent day.

The suspension of power shall be effective after 15 days from the date of issuance of this letter. Regarding diversion/absorption of regulated share, if any response from the constituents is received, the same will be communicated to RLDC. As per requirement of CERC (Regulation of power Supply) Regulation, 2010 DVC is also posting Regulation Notice on DVC website http:// www.dvc.gov.in.

The proposed regulation of power would be implemented w.e.f 00:00 hrs of 25.02.2020 as per CERC Regulation/PPA. JBVNL will be liable to pay the Fixed charges during the regulated period. A copy is being sent to SLDC, DVC Howrah to prepare implementation plan for regulation of power supply to JBVNL & implement the same as per procedure laid down by CERC (Regulation of power Supply) Regulations, 2010 and list of constituents who would avail the regulated power would be given to ERLDC within a week time.
