Gist of the application for approval of Power Purchase Agreement

1. Damodar Valley Corporation (DVC) has made an application on 03.02.2022 before the West Bengal Electricity Regulatory Commission (Commission) for approval of Power Purchase Agreement dated 18.12.2020 read with addendum dated 15.09.2021 executed by and between DVC and M/s Jyotikiran Energy Mumbai Private Limited. Subsequently, DVC has also submitted a supplementary application on 13.05.2022 for approval of purchase of 165.49 kWp Solar Power from Jyotikiran Energy Mumbai Private Limited to be installed at Raghunathpur Thermal Power Station, DVC, District - Purulia, West Bengal, for a period of 25 years from the date of Commercial Operation at the Tariff determined through competitive bidding in terms of regulation 7.4 of the West Bengal Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2011 as amended. The applications dated 03.02.2022 and 13.05.2022 submitted by DVC has been admitted by the Commission on 28.02.2022 in Case No. PPA-117/21-22.
2. Salient Points of the Power Purchase Agreement:
 - a) **Nature of Generation Plant:** Grid Connected Rooftop Solar Photo Voltaic Power Plant.
 - b) **Specific Source:** Grid Connected Rooftop 165.49 kWp Solar Photo Voltaic Power Plant to be installed at Raghunathpur Thermal Power Station, DVC, West Bengal.
 - c) **Contract period:** 25 years from the date of Commercial Operation Date.
 - d) **Contracted capacity:** 100% of the Solar power generated by the 165.49 kWp Solar Power Project.
 - e) **Tariff:** Determined through competitive bidding at Rs. 3.33 per kWh (which is at the levelized tariff as per SECI allocation).
 - f) All charges and losses beyond the delivery point to be borne by DVC.
3. The objections and suggestions, if any, on the proposals contained in the applications may be submitted at the office of the Commission at the above-mentioned address within 21 days (from 11 AM till 5 PM), from the date of publication (including the date of publication) of this notice in the newspapers.
