Gist of Tariff order dated 13.03.2024 passed by the West Bengal Electricity Regulatory Commission for the years 2023-24 and 2024-25 in Case No. TP-104/22-23

- 1. The West Bengal Electricity Regulatory Commission (Commission) in terms of the West Bengal Electricity Regulatory Commission (Terms and Conditions of Tariff) Regulations, 2011, as amended (Tariff Regulations 2011) has determined the Aggregate Revenue Requirement (ARR) for the years 2023 24, 2024 25 and 2025 26 of the 8th control period and revenue recoverable through tariff and retail tariff for the years 2023 24 and 2024 25 in Case No. TP-104/22-23 for distribution activity of DVC in the State of West Bengal based on the tariff application of DVC for the 8th control period and suggestions, objections and comments received from the stake holder on the aforementioned application.
- 2. The revenue to be recovered through tariff and Average Tariff for the years 2023 24 and 2024 25 are as below:

The tariff schedule as applicable to consumers of DVC in West Bengal are specified in Annexure-6A1, 6A2 and Annexure-6B1, 6B2 of the tariff order dated: 13.03.2024 which is also available on the website of DVC at www.dvc.gov.in.
- 4. All the rates and conditions of tariff mentioned above are effective from 1st April 2023 for FY 2023-24 and from 1st April 2024 for FY 2024-25 and will continue till further order of the Commission.
- 5.
