A. Damodar Valley Corporation (DVC) invites bid from eligible bidders from eligible bidders on e-Tendering mode on **Single Stage Three Envelope Bidding Basis** for aforesaid package as per the brief Scope of Work mentioned hereinafter.

B. BRIEF SCOPE OF WORK

The brief scope of work for "EPC Package (Excluding STG Pkg.)" for DVC Raghunathpur Thermal power station, Phase-II (2x660 MW) is as follows:

Design, Engineering, Manufacture, Supply, Construction, Erection, Testing & Commissioning works for the EPC Package(Excluding STG Pkg.) for DVC Raghunathpur, Stage-II (2x660 MW), on the basis of single point responsibility, completely covering the following activities and services in respect of Steam Generator, Electrostatic Precipitator, Flue Gas Desulphurization system, Biomass firing, Water Treatment plant, chlorination system, CW system with IDCT, Equipment cooling water system, Compressed air (instrument & service air) system, air conditioning & ventilation system, fire detection & protection System, Coal and Biomass Handling system inside plant, Ash Handling system, Fuel Oil pressurizing system, Extension of existing switchyard with associated bays for Stage-II GTs & STs, Replacement of Existing Bus reactors with 125MVAR Bus reactors, all electrical systems, complete Control & Instrumentation, complete Civil, Structural and Architectural works, Rooftop Solar PV Plants at buildings covered under the specifications:

- a) Basic Engineering of the plant including preparation of Plant Definition Manuals.
- b) Detailed design of all the equipment and equipment system(s) including civil, structure steel & Architectural works included in bidder's scope.
- c) Providing engineering drawings, equipment sizing & performance data, instruction manuals, as built drawings and other information.
- d) Compliance with statutory requirements and obtaining clearances from statutory authorities, wherever required.
- e) Complete manufacturing including shop testing/type testing.
- f) The complete Civil, structural and architectural works as specified in Section-VI, PART-A, Sub-section-IID and other sections of the Technical Specification.
- g) Packing and transportation from the manufacturer's works to the site including logistic studies, insurance, customs clearance & port clearance, port charges, if any.
- h) Receipt, storage, preservation, handling and conservation of equipment at the site;
- i) Fabrication, pre-assembly, if any, erection, insurance, testing, commissioning and completion of facilities including putting into satisfactory operation all the equipment

- including successful completion of initial operation.
- j) Performance and guarantee tests Along with initial operation.
- k) Supply of spares on FOR site basis;
- l) Reconciliation with Customs Authorities.
- m) Satisfactory conclusion of the Contract.
- n) Insurance and other requirements
- o) The plant shall be ZLD compliant

- C. DVC intends to finance the aforesaid Package through Term Loan from Banks and/or FIs /ECB/World Bank/ADB etc./issue of long-term bonds.
- D. **Only Class-I local suppliers are eligible to Bid. Bids received (if any) from Class-II Local Supplier / Non Local Supplier shall be out rightly rejected.**
