1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 4. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. 6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. 8. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

i) **PRICE BASIS:**

The Contract Price shall be FIRM & FIXED during the entire execution of the Contract and shal I not be subject to any variation except on account of Statutory Variation on direct transactio n between the Employer (DVC) & the Contractor.

Landed Price of Coal shall be payable to the Agency based on the methodology outlined in th is **Volume-IV: Scope of Work, Technical Specification and Other Terms & Condition s.**

ii) TAXES, LEVIES AND DUTIES shall be as below:

- (a) Except as otherwise specifically provided in the Contract, the Contractor shall bear and p ay all taxes, duties, levies, cess, etc. and charges assessed on the Contractor, its Subcont ractors or their employees by all municipal, state or national government authorities in co nnection with the Facilities in and outside of the country where the Site is located.
- (b) All taxes, duties, levies, royalties, fees, cess, etc in respect of the works, supply and all ot her services to be done by the Contractor as per the specifications of Bidding Documents and also taxes, duties, cess & levies as may be applicable on the materials used for the w orks, supply shall be to the contractor's account & included in the Contract Price. The Co ntract price (for GCV: 3550 Kcal/ Kg alongwith base parameters of domestic coal as specified in Annexure-B1 to Volume -IV of the Bid Document) shall be in clusive of Freight, GST, GST Compensation Cess & all other taxes, duties, levies , royalty, cess, fees etc. on FOR Basis.
- (C) However, if DVC pays any taxes, duties, levies, cess, etc directly to the concerned statut ory authorities, the same will be deducted from contractor's bill.

iii) MODE OF SUPPLY & DELIVERY PERIED:

Coal indigenously produced within India including commercial mines (shall also be termed do mestic coal) of specifications mentioned herein given at **Annexure-B1** in **Volume-IV: (Sco pe of Work, Technical Specification and Other Terms & Conditions) of Bid Docume nt** on "FOR Destination" basis at DVC power stations for quantities given at **Annexure-B2** in **Volume-IV: (Scope of Work, Technical Specification and Other Terms & Condition s) of Bid Document** through Indian Railways. The Agency is free to opt the transportation mode for sourcing coal from mines but ultimately coal shall be delivered to DVC stations through Indian Railways. The timely supply of domestic coal as per the delivery schedule is the e ssence of contract. The total quantity of domestic coal for each station shall be delivered to s tations, as per the delivery schedule to be given to the Agency by DVC. Delivery schedule for r each station shall be given subsequently to the Agencies after acceptance of LOA. Delivery schedule may be extended further at the sole discretion of DVC.

However, validity of contract shall be 06 months from the date of placement of or der.

iv) **TRANSIT INSURANCE:**

As per clause no. 9 of General Conditions of Contract (GCC) & Debarment Policy of DVC.

v) **<u>PAYMENT TERMS:</u>**

- a) No advance payment will be made to the Agency. Payment will be made on rak e-to-rake basis.
- b) **Initial payment** against the net adjusted received coal based on the coal anal ysis results at DVC Laboratory for 50% of the total landed cost to be paid to the Agency within 15 days from the receipt of invoice and Railway Receipt (RR).
- c) **Interim payment** of Balance 40% will be paid after receipt of CIMFR/ 3rd Part y Sampling Agency analysis results subsequent of quantity and quality adjustm ent after monthly reconciliation.
- d) **Final payment** of 10% will be paid after final reconciliation.
- e) **Sampling charges** at unloading end will be shared equally (50% -50%) buyer and Seller. Rake-to-Rake sampling charges based on the quantity received will b e deducted from the running bill.
- f) Railway freight will be reimbursed/payable as per actuals, limited to the quote d transportation/freight cost after quality & quantity adjustment in line with the clause No.14 in Volume-IV: (Scope of Work, Technical Specification and Other T erms & Conditions) of Bid Document on submission of invoice and Railway recei pt (RR). However, payment to receipt quantity & applicable freight charges will be limited to RR weight & freight charge. Besides, variation in railway freight tariff, if any, shall be dealt for the purpose of payment/adjustments, in line with clause No.14 in Volume-IV: (Scope of Work, Technical Specification and Other T erms & Conditions) of Bid Document. The term "Railway freight", wherever use d, shall imply Base Railway freight plus any surcharge(s) as levied by Railways.

vi) <u>SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE:</u>

Within Fourteen (14) days from the date of issuance of Letter of Award (LOA)/ Work Order (W O)/Purchase Order (PO), the successful Bidder (s) shall furnish performance security for satisfactory execution of the order for an amount equivalent to 10% of the Letter of Award (L OA)/ Work Order (WO)/Purchase Order value in the form of Insurance Surety Bonds, account payee demand draft, fixed deposit receipt from a commercial bank, bank guarantee issued/ confirmed from any of the commercial bank in India or online payment in an acceptable form , safeguarding DVC's interest in all respects.

In case of Performance Security in form of Bank Guarantee, the bidder may furnish an Uncon ditional Bank Guarantee as per GeM format from any Nationalised / Scheduled Bank and it s hould remain valid for a period of 60 (sixty) days beyond the date of completion of all contra ctual obligations of the contractor, including Defect Liability Period (DLP)/ warranty period, a s applicable.

If the Contractor fails to submit the performance security within 30 days of the date of issuan ce of LOA/PO/Work Order, DVC without prejudice to any other rights or remedies it may poss ess under the Contract, may forfeit the bid security (wherever applicable) and shall short clo se the Contract and retender and in this re-tender such defaulting Bidder will not be allowed to participate.

Other terms & condition SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE as notwithstan ding in tender document shall be as per DVC's GENERAL CONDITIONS OF CONTRACT (GCC) a nd Debarment Policy of this Bidding Documents.

vii) AGREEMENT CLAUSE:

Contracts shall be executed as per format attached in Vol-V: Bid Forms & Procedures (BFP) a fter receipt and verification of the requisite performance security (wherever applicable). The said agreement will be duly signed by the authorised representative of DVC and authorised signatory of Supplier/Contractor/ Service Provider/Consultant.

Within 7 days from the date of issue of LOA/PO/Work Order, DVC will send the agreement to the Supplier/Contractor/ Service Provider/Consultant for signature, incorporating all agreeme nts between the parties for execution.

The Supplier/Contractor/ Service Provider/Consultant should acknowledge and unconditionall y accept, sign, date and return the agreement within 14 days from the date of issue of LOA/P O/Work Order. If both parties simultaneously sign the contract across the table, further ackn owledgement from the supplier is not required.

Non- execution of Contract Agreement by the Supplier/Contractor/Service Provider within 30 days from the date of issue of LOA/PO/Work Order due to the fault of the Supplier/Contractor/

Service Provider, will constitute sufficient ground for forfeiture of its EMD (wherever applicabl e) and shall short close the Contract and retender and in this re-tender such defaulting Bidd er will not be allowed to participate.

viii) <u>CONTRACT PERIOD</u>:

The Contract shall remain valid for 06(six) months from the date of issuance of contract.

ix) L.D CLAUSE:

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the origin al/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/re cover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delaye d quantity without any controversy/dispute of any sort whatsoever.
