## Section - II

Brief Description of Job & QR for selecting prospective bidders (Tentative)

1. Tubed Coal Mine of Damodar Valley Corporation (DVC) is situated in <u>Tubed, Dihi, Mangra, Newari, Ambajharan, Dhobiajharan villages in Latehar District of Jharkhand State. The mine is located about 15 kilometers from Latehar Town.</u>

Tubed Coal Mine has a Peak Rated Capacity of 6.0 Million Tonnes per Annum and may be increased upto 9.0 Million Tonnes per Annum.

Pipe Conveyor (Double Stream) starting from Tubed Coal Mine and terminating at a proposed siding at Demu Block Halt Station with development of a Coal rake Siding suitable is under examination.

- In this regard, DVC invites Expression of Interest (EOI) from any Company / their Consortium / Affiliates/Representatives having any Legal Entity in India (hereinafter called APPLICANT). The participation in EOI may also be done through consortium; however,the consortium shall have a lead partner.
- 3. INTENT/OBJECTIVE OF THE EXPRESSION OF INTEREST (EOI):

The objective of this Expression of Interest (EOI) is to obtain the techno economical details along with terms and conditions for preparation of QR, Terms & Conditions etc. of Final NIT towards the following:

- a. The design, supply, installation, testing, commissioning and operation of the Pipe conveying system of 2500 TPH or beyond capacity to cater peak rated dispatch 9 MMT per Annum.
- b. The development of a Coal rake Siding suitable for loading of a maximum 10 coal rakes per day with and without silo arrangement so as to achieve a peak rated coal dispatch of Nine (9) million metric ton per annum.
- 4. Scope of Work: The Scope of Work is for preparation of a "Detail Project Report for proposed coal evacuation arrangement from Tubed Coal Mine to Indian Railway Network at Demu Railway Station through Pipe Conveyor (Double Stream) and Wagon loading arrangement at Demu Railway Station".

#### A. For Pipe Conveyor:

- 1.0 General Reconnaissance Survey of the area between Tubed Coal Mine and Demu Station for finalizing one technically feasible and cost-effective alignment of Pipe Conveyor.
- 2.0 Reconnaissance Survey of the area of Tubed Coal Mine for locating suitable loading arrangement in consultation with the officials of DVC.
- 3.0 Preliminary Engineering Survey shall be carried out with Total Station/ other instrument for the proposed alignment of Pipe Conveyor.
- 4.0 To prepare all concerned Engineering layout plans for the proposed Pipe Conveyor infrastructure including loading and unloading facilities, transfer points etc.
- 5.0 The entire coal conveying system shall operate at a height of about 3 meters to avoid coal

pilferage & material thefts and shall be elevated/ reduced to standard heights as per statutory requirement where5ver the system crosses National Highway, District & Local roads, Nallas, OHT lines etc.

6.0 Preparation of anticipated cost estimate for Civil, Mechanical, Electrical and Control & Instrumentation Engineering works etc.

#### B. For Loading arrangement at Demu Railway Station:

- 1.0 Reconnaissance Survey of the area of Demu Railway Station for locating suitable take-off and loading arrangement in consultation with the officials of DVC & Railways.
- 2.0 Preliminary Engineering Survey shall be carried out with Total Station/ other instrument for the proposed alignment of Pipe Conveyor.
- 3.0 To prepare Engineering (Civil, Mechanical, Electrical, S&T etc) layout plans for the proposed railway infrastructure including loading arrangement, meeting points with existing railway network etc.
- 4.0 Preparation of anticipated cost estimate for Civil Engineering, Mechanical Engineering, Electrical Engineering, Control & Instrumentation Engineering, Signal & Telecom etc.
- 5.0 To evolve system of working for operation of train services.
- 6.0 Preparation of Feasibility Report/ Detail Project Report and its approval from the Railway.

# C. For Both A & B(i.e. for both Pipe Conveyor and Loading arrangement at Demu Railway Station.

- 1.0 Preparation of detailed layout plan on a suitable scale.
- 2.0 Soil investigation at appropriate distance intervals of the route of Pipe Conveyor and also loading arrangement at Tubed Coal Mine & unloading at Demu Railway Station to ascertain the sub soil strata.
- 3.0 Hydrological investigation of river, nallah or any other water bodies which come across the proposed alignment.
- 4.0 Detailed structural design of sub-structure, super structure and detail working drawing of the Pipe Conveyor and loading arrangements at Tubed Coal Mine and Demu Railway Station.
- 5.0 Preparation of land schedule to assess land requirements with classifications. This shall also be marked on Mouza Maps (Collection of Mouza Maps shall be the responsibility of the agency).
- 6.0 Time Schedule for execution of the project and commissioning.

7.0 The Detail Project Report shall include total land requirement with details for the coal conveying system to enable Tubed coal Mines to acquire the land, if necessary.
